### **HealthSpace Signs Tennessee Department of Health as Pilot Partner for “My Health Department.com”**

**VANCOUVER, BC – February 11, 2019** - HealthSpace Data Systems Ltd. Further, working with one of world’s largest provider of online payments means these tools will be streamlined providing significant value-add to both government agencies and private businesses.

We are excited to begin working with the regulators in Tennessee to guide the platform’s initial features to ensure that, long term, this turns into a national success.
