of dried pasta, supported by a line-up of specialty ingredients for commercial food producers.

On September 21, 2023, the landlord of the premises leased by Nepra Foods, Ltd., the Issuer's wholly owned subsidiary, filed a claim against Nepra Foods, Ltd. for overdue rent in the District Court in Arapahoe County, in the State of Colorado. The claim is in the amount of USD\$248,862.08. The Company is working with it's counsel to negotiate a resolution with the landlord.

13. Provide details of any indebtedness incurred or repaid by the Issuer together with the terms of such indebtedness.

Nepra Foods Ltd., the issuer's wholly owned subsidiary, entered into a short term loan secured by accounts receivable with Web Bank, Salt Lake City UT. In the amount of US\$53,835. (CAD\$72,677). Terms are 12 months at 15% per annum.

14. Provide details of any securities issued and options or warrants granted.

On September 28, 2023, the Company closed the first tranche of the private placement initially announced on September 13, 2023, issuing 12,201,100 units for gross proceeds of \$610,055. Each unit consists of one common share in the capital of the Company and one common share purchase warrant. Each warrant will enable the holder to purchase on additional share at a price of \$0.10 for a period of 24 months following date of issue of the warrant.

As of September 30, 2023, the issuer owed a loan balance of US\$661,555 (CAD\$874,973) to Robert G. Wood and Company Inc., a company controlled by David Wood (the interim CFO, COO, Interim Corporate Secretary and Director of Nepra Foods Inc.). This balance consists of principal and interest which accumulates at 6% per annum
